If you receive a confirmation email stating that you have a spot, you must come to the Tiny Tots classroom on Feb 1, 2022 at 6:30 pm to fill out paperwork. Do not come to the classroom if you receive an email stating you are on the wait list. Registration is on a first come basis. Snow date for confirmed students is Feb 8, 2022. Children must be 3 or 4 years old by 9/1/22. Classes are limited to 20 children. Because of pre-registration and alumni registration there may be limited space in the 3 and 4-year-old classes. Availability will be posted on WMRC website. **Once the classes are full, we will start the waiting list**
